The total amount of the HEERF II Grant received from the Department, pursuant to the institution's Certification and Agreement CRRSAA Grants to Students, that was to be disbursed to Students was \$31,690.00.

The total amount of the Grant Funds distributed to students under HEERF II Grant Funds for Students as of this report dated above is \$31,690.00. The funds have been completely distributed.

The total number of students who have received a Higher Education Emergency Relief Fund (HEERF II) Grant is <u>37</u> as of this report dated above.

Eligibility was based on all students currently enrolled on 1/22/2021, and still currently enrolled, or on a Leave of Absence, or graduated at the time of receipt of funds.

The amount of each disbursement to students was determined by the Students 20/21 EFC. If a 20/21 EFC was not on file but a 19/20 EFC was on file, 19/20 EFC was used. If multiple EFC's on file, the EFC from the most recently received ISIR was used. If no EFC was on file, student was counted as "no EFC".

Students were awarded as follows: 0 EFC- \$1,100.00 award amount 1-5711 EFC- \$750.00 award amount 5712 EFC or higher and no EFC- \$622.31 award amount

Student were required to complete an "award notice" indicating how they wanted funds applied. Grant Funds were processed after receipt of students signed "award notice." Students were required to sign a Student Acknowledgement and Certification of Understanding of the Higher Education Relief Fund Grant (HEERF II) upon receipt of Grant Check and / or ledger showing their requested payment amount applied to their school balance.
